**Markets start at 9:00 am and end at 1:00 pm except for the September 3rd market starts at 4:00 pm and ends at 8:00 pm and December 3rd market starts at 11:00 am and ends at 2:00 pm.**

Vendor spaces are not reserved until full payment is received, failure to pay will result in vendor ineligibility for future markets. Please call 567-342-4758 to make payment over the phone and complete the registration form. No refunds.

**Please remember that registration form and payment must be received **in hand** by Downtown Fremont Inc. to make lineup and to be promoted on social media.**

# Fremont Farmers Market 2022 Rules & Regulations

1. All vendors must register with Downtown Fremont Inc. by filling out a registration form.
2. There is a registration fee that must be paid **PRIOR** to the market to be put on the map, receive marketing and/or to set-up.
3. Vendors are expected to sell what they produce (absolutely no dock or warehouse produce allowed). Downtown Fremont Inc. recognizes that the June market is early for local produce, therefore if you are selling produce at that market that is not grown by you it should be clearly labeled as such. We allow homemade bake goods, cheeses, jams, salsa, honey, soaps, lotions, etc., provided the processed foods have met all the State and Local regulations.
4. The sale of live animals and flea market items are prohibited unless the vendor obtains advanced authorization from Downtown Fremont Inc.
5. All vendors need to be present or in the process of setting up **at least a half hour** before the market to ensure the safety of the other vendors and participants. Vendors that fail to show or call/text 567-342-4758 of an absence or late arrival will be subjected to vendor ineligibility for future markets.
6. Vendors must comply with all laws, ordinances, and regulations of the United States, State of Ohio and the City of Fremont (which uses the Sandusky County Board of Health regulations and inspectors).
7. It is the vendors responsibility to obtain all the licenses, permits and pay the fees required by Local and State bodies. This includes a vendor's license for goods sold for which a sales tax must be collected and paid. Baked goods fall under cottage law and a license does not need to be obtained:

  - To obtain a temporary license to cook and sell food or sell retail food, you must contact Sandusky County Public Health **10 days** in advance of your event 419-334-6377.
  - A transient vendor's license number must be provided on the Farmer's Market registration form. It is used to register your business with the State of Ohio and identifies your business when paying sales tax on retail sales or orders on retail sales. The cost of the license is \$25.00 and it is good until it is cancelled.
    - To obtain a transient vendor's license please fill out the attached application. We encourage you to apply for your transient vendor's license as early as 6 weeks prior to the Farmers Market you wish to participate in to ensure your application has been received. To help expedite this process you may call 800-282-1782.
8. Individuals, groups, organizations or businesses providing concessions must clearly state what they intend to sell at each market on the Downtown Fremont Farmer's Market registration form. Food vendor spaces are reserved on a first come, first served basis when accompanied with payment in full.
9. Downtown Fremont Inc. may limit the number of vendors selling the same or similar products at a market or vendors who are in direct competition with downtown businesses.
10. Vendors are to only have **ONE** product per booth. No double dipping of sales.
11. Payment for the Farmers Market is the cost of participating for a 12x10 ft. space.

12. 110 and limited 220 electrical services are available for an additional \$10.00 per market unless a food vendor which is included in market price.
13. Downtown Fremont Inc. reserves the right to refuse a registration or vendor from participating.
14. Downtown Fremont Inc. will assign vendors a numbered space that is approximately 12x10 ft. and is located down the middle of Front Street. Vendors set up facing the businesses up against the solid yellow lines in the middle of the street. Tents and tables should not cross the solid yellow lines.
15. Vendors may not, at any time, set up on the sidewalk which goes for Downtown Businesses allowing vendors to set up in front of their businesses too. All vendors must adhere to fire and safety rules and regulations.
16. Set up begins 2 hours before the start of the market. All vendors must be set up or in the process of setting up half hour before the market is to start. All markets begin at 9:00 am and end at 1:00 pm except September 3rd market starts at 4:00 pm and ends at 8:00 pm and December 3rd market starts at 11:00 am and ends at 2:00 pm . This is a rain or shine event.
17. Tables, tents and weights are **NOT** provided and are the responsibility of the vendor. Vendors who use tents are highly encouraged to secure them with portable weights. Tent stakes may **NOT** be used. Any type of generator may **NOT** be used.
18. Vendor displays must not impede pedestrian traffic or vehicular traffic on the street.
19. Vendors set their own prices for products they are selling.
20. Activities and sales are limited to assigned spaces only. Vendors and/or Downtown Businesses are not permitted to roam the market to campaign, make sales or disseminate information. No solicitation allowed - Chapter 733 Peddlers and Itinerant Vendors:

21. No loud radios or shouting of prices.
22. No smoking in vendors areas. For the health and safety of all our vendors and visitors, vendors are prohibited to smoke in the vendor area. Please be considerate of the downtown businesses in regard to this issue as well.
23. Vendors are to clean their areas: remove all produce, containers, signs, trash and messes at the end of the market.
24. Downtown Fremont Inc. is comprised of staff and volunteers. Please treat them kindly. Everyone is here to make the market a success!
